ORDER

On January 9, 2009, the Power Sector Assets and Liabilities Management Corporation (PSALM) filed a "Petition for the Adoption of Proposed Assets Valuation Guidelines."

Acting thereon, the Commission issued a Notice of Public Consultation dated January 12, 2009 setting the said Petition for public consultation on **February 23, 2009 (Monday) at two o'clock in the afternoon (2:00 P.M.) at the Energy Regulatory Commission (ERC) Hearing Room, 15th Floor, Pacific Center Building, San Miguel Avenue, Pasig City.**

PSALM is hereby directed to cause the publication of the attached Notice of Public Consultation, at its own expense, twice (2x) for two (2) successive weeks in two (2) newspapers of general circulation in the Philippines, with the date of the publication to be made not later than ten (10) days before the date of the scheduled public consultation. It is also directed to inform the consumers, by



any other means available and appropriate, of the filing of the said proposed Petition, its reasons therefor, and of the scheduled public consultation.

On the date of the public consultation, PSALM must submit to the Commission its written Compliance with the said directive attaching therewith the evidences on the publication of the Notice of Public Consultation consisting of the affidavits of the Editors or Business Managers of the newspapers where the said Notice of Public Consultation was published together with the complete issues of the said newspapers, and such other proofs of compliance with the requirements of the Commission.
