

INVITATION TO BID

for

Security Services for Various Power Plants

1. The Power Sector Assets and Liabilities Management Corporation (PSALM) Bids and Awards Committee (BAC) invites prospective bidders duly registered with the Philippine Government Electronic Procurement System (PhilGEPS), to participate in and bid through public bidding for the procurement of Security Services ("the Goods") for its various power plants. Through its 2010 Corporate Operating Budget, PSALM intends to apply the sum as indicated below being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Security Services for the hereunder Plants:

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. Delivery of the Goods is required as indicated in the **Bid Data Sheet** of the Bidding Documents. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible Bidder is contained in Section II of the Bidding Documents, Instructions to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty

percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested Bidders may obtain further information from Power Sector Assets and Liabilities Management Corporation and inspect the Bidding Documents at the address given below from 9:00 AM to 5:00 PM, Monday to Friday.
5. A complete set of Bidding Documents may be purchased by interested Bidders beginning on **02 March 2010** from the address below and upon payment of a nonrefundable fee as indicated above. The method of payment will be either in cash or in check. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The Power Sector Assets and Liabilities Management Corporation will hold a Pre-Bid Conference on **09 March 2010** at 10:00 AM at the 6th Floor, Bankmer Building, 6756 Ayala Avenue, Makati City which shall be open to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below before 10:00 AM, **22 March 2010**. All Bids must be accompanied by a Bid security in any of the acceptable forms and in the amount stated in ITB clause 18.
8. Bid opening shall be on **22 March 2010** at 10:15 AM at the 6th Floor, Bankmer Building, 6756 Ayala Avenue, Makati City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late Bids shall not be accepted.
9. The Power Sector Assets and Liabilities Management Corporation reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
