Bidders are limited to Waste Oil Treaters with Treatment, Storage and Disposal Facility with an Environmental Compliance Certificate (ECC) issued by Environmental Management Bureau of the Department of Environment and Natural Resources (DENR-EMB). Such ECC should state a waste oil treatment capacity of at least eleven thousand one hundred eleven (11,111) liters per day;
5. Interested parties must have no unfinished project, current conflict or dispute with the Seller.
6. Bidding will be conducted through an open competitive bidding using a non-discretionary "pass/fail" criterion.
7. A complete set of Bidding Documents may be purchased by interested parties beginning on **24 November 2016** until one (1) day prior to Bid opening from the address below and upon payment of a nonrefundable fee of **PhP13,000.00**.
