**1. NOTICE TO BIDDERS**

Bidders are hereby notified of the amendments, revisions, modifications and clarifications to the Bidding Documents dated 24 January 2020 for the Procurement of Operation and Maintenance Service Contract for the Malaya Thermal Power Plant located at Pililla, Rizal.

In compliance with the order of President Rodrigo Roa Duterte raising the Code Alert System for the novel coronavirus disease 2019 (COVID-19) in the country to Code Red Sublevel 2, PSALM has institutionalized office policies adopting stringent social distancing measures as well as the formation of skeletal workforce that will ensure that critical, urgent and necessary functions of PSALM are completely performed and the mandates and objectives of PSALM are still timely accomplished, while drastically minimizing any health risks on the PSALM personnel and prospective bidders.

This Supplemental Bid Bulletin, therefore, is being issued in light of the above-mentioned order of President Duterte.

In any case, it is conclusively presumed that the Bidder, in preparing their bids, has taken into account the information and procedures set forth in the ITB.
