

49 The BAC Chairperson asked the BAC Secretariat if observers were invited
50 which the BAC Secretariat replied in the affirmative but stated that though
51 invited, no observers attended the pre-bid conference.
52

53 The BAC Chairperson introduced the members of the BAC and TWG and
54 acknowledged the presence of the representatives of the two (2) interested
55 bidders, namely: APLSSC and GSSI.
56

57 The BAC proceeded with the pre-bid conference. The TWG presented and
58 discussed the Bidding Documents to the bidders.
59

60 The BAC reiterated that “no contact rule” is strictly implemented between
61 the members of the BAC, BAC Secretariat, TWG and the bidders.
62

63 **2. Presentation of the Bidding Document and Clarification from the Bidder**

- 64
- 65 ○ The TWG presented and discussed the Bidding Documents.
66
- 67 ○ The BAC reiterated that bidders may submit either their Class “A” Documents
68 in accordance with Section 23.1(a) of the IRR or the PhilGEPS Certificate of
69 Registration and Membership under Platinum Category, or a combination
70 thereof. The BAC clarified that if the documents comprising the Annex of the
71 PhilGEPS Certificate are not updated, the bidder shall also submit the
72 updated documents. However, if all were updated, only the PhilGEPS
73 Certificate shall be submitted.
74
- 75 ○ The TWG informed the bidders that a Supplemental Bid Bulletin will be issued
76 for the change of time of bid submission from 10:00 am to 1:00 pm and the
77 opening of bids from 10:30 am to 1:30 pm.
78
- 79 ○ Mr. Oquendo of APLSSC inquired if white shirt with collar with company logo
80 and has a print of the word “security” is acceptable for type B uniform for
81 roving guard. The BAC replied affirmatively if it complies with the
82 requirement of a type B uniform.
83
- 84 ○ The BAC and TWG informed the bidder that there will be meeting to be
85 scheduled for all winning bidders on the preparation and submission of
86 billings.
87
- 88 ○ Ms. Constantino of GSSI asked if the new SSS table effective on April 2019 will
89 not be applied. The BAC replied that corresponding Supplemental Bid Bulletin
90 will be issued.
91
- 92 ○ Ms. Constantino further inquired about the 20% floor as prescribed by the
93 Department of Labor and Employment. The BAC replied that since the project
94 is undertaken by a government entity, the floor is not applicable as provided
95 under Republic Act No. 9184 and its 2016 Revised Implementing Rules and
96 Regulations.
97

- 98 ○ The BAC advised the bidders that when buying the bidding documents, they
99 must first get an 'Order Form' from the BAC Secretariat. They must also
100 provide their Certificate of Registration (if first time to bid with PSALM Corp.)
101 then pay the corresponding fee with the Cashier's Office. Upon presentation
102 to the BAC Secretariat of the official receipt issued by the Cashier, they can
103 now get the Bidding Documents.
