- 1. DECLARATION OF FAILURE OF BIDDING; AND**
- 2. CONDUCT OF RE-BIDDING**

**FOR THE PROCUREMENT OF ADDITIONAL TWO (2) LICENSES OF RAD
STUDIO ARCHITECT EDITION
(PROJECT REFERENCE NO. 2021-SVP-RAD-032-01)**

WHEREAS, the Power Sector Assets and Liabilities Management (PSALM) Corporation is a government-owned and -controlled corporation duly established under Republic Act (RA) No. 9136 to manage the privatization of assets of the National Power Corporation (NPC) transferred to PSALM with the objective of liquidating all NPC financial obligations in an optimal manner;

WHEREAS, RA 9184, otherwise known as the Government Procurement Reform Act, was enacted to modernize, standardize and regulate procurement activities governed by the principles on transparency, competitiveness, system of accountability, public monitoring and streamlined process;

WHEREAS RA 9184 likewise provides that all procurement should be within the approved budget and contained in the approved Annual Procurement Plan (APP);

WHEREAS, on 18 December 2020, the PSALM Board of Directors approved the APP for CY 2021 which includes the Procurement of RAD Studio (the "Project") with an estimated budget of Two Million Pesos (PHP2,000,000.00);

WHEREAS, on 27 May 2021, the PSALM President and CEO approved the Revised APP for the Procurement of RAD Studio changing the mode of procurement from Public Bidding to Negotiated Procurement (Small Value Procurement);

WHEREAS, on 25 June 2021, the Invitation to Submit Proposal for Procurement of Additional Two (2) Licenses of RAD Studio Architect Edition with Project Reference No. 2021-SVP-RAD-032-01 (the "Project") with an Approved Budget for the Contract (ABC) of Eight Hundred Thousand Pesos (PHP800,000.00) was posted at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalm.gov.ph>) and at the PSALM Office;

WHEREAS, on 29 June 2021, no bidder submitted proposals before the deadline for the submission at 3:00 PM;


WHEREAS, Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, RESOLVE, as it is hereby RESOLVED, to recommend for approval by the Head of the Procuring Entity the following:

1. Declare a **FAILURE OF BIDDING** for the Procurement of Additional Two (2) Licenses of RAD Studio Architect Edition; and
2. Conduct a re-bidding for the Project in accordance with the provisions of RA 9184 and its IRR.




