BAC RESOLUTION NO. SBAC-2021-069

- 1. DECLARATION OF SECOND FAILURE OF BIDDING; AND**
- 2. RECOMMENDATION FOR CONDUCT OF RE-BIDDING**

**FOR THE PROCUREMENT OF ADDITIONAL TWO (2) LICENSES OF RAD
STUDIO ARCHITECT EDITION
(PROJECT REFERENCE NO. 2021-SVP-RAD-032-02)**

WHEREAS, the Power Sector Assets and Liabilities Management (PSALM) Corporation is a government-owned and -controlled corporation duly established under Republic Act (RA) No. 9136 to manage the privatization of assets of the National Power Corporation (NPC) transferred to PSALM with the objective of liquidating all NPC financial obligations in an optimal manner;

WHEREAS, RA 9184, otherwise known as the Government Procurement Reform Act, was enacted to modernize, standardize and regulate procurement activities governed by the principles on transparency, competitiveness, system of accountability, public monitoring and streamlined process;

WHEREAS RA 9184 likewise provides that all procurement should be within the approved budget and contained in the approved Annual Procurement Plan (APP);

WHEREAS, on 18 December 2020, the PSALM Board of Directors approved the APP for CY 2021 which includes the Procurement of RAD Studio with an estimated budget of Two Million Pesos (PHP2,000,000.00);

WHEREAS, on 27 May 2021, the PSALM President and CEO approved the Revised APP for the Procurement of RAD Studio changing the mode of procurement from Public Bidding to Negotiated Procurement (Small Value Procurement);

WHEREAS, on 22 June 2021, the pre-procurement conference was conducted wherein the Bids and Awards Committee (BAC) approved the Request for Proposal (RFP), the Approved Budget for the Contract (ABC) of Eight Hundred Thousand Pesos (PHP800,000.00) and the timeline for the procurement;

WHEREAS, on 25 June 2021, the Invitation to Submit Proposal for Procurement of Additional Two (2) Licenses of RAD Studio Architect Edition (Project Reference No. 2021-SVP-RAD-032-01) (the "Project") with an ABC of Eight Hundred Thousand Pesos (PHP800,000.00) was posted at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM

(<https://www.psalm.gov.ph>) and at the PSALM Office. The Invitation to Submit Proposal was also sent to at least three (3) suppliers of known qualifications;

WHEREAS, on 30 June 2021, the BAC, through BAC Resolution No. SBAC-2021-039, declared a failure of bidding for the Project with Project Reference No. 2021-SVP-RAD-032-01 pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations of RA 9184 and to conduct a re-bidding in accordance with RA 9184 and its IRR;

WHEREAS, on 22 July 2021, the pre-procurement conference was conducted wherein the BAC approved the RFP, the ABC of Eight Hundred Thousand Pesos (PHP800,000.00) and the timeline for the procurement;

WHEREAS, on 28 July 2021, the Invitation to Submit Proposal for Procurement of Additional Two (2) Licenses of RAD Studio Architect Edition (Project Reference No. 2021-SVP-RAD-032-02) with an ABC of Eight Hundred Thousand Pesos (PHP800,000.00) was posted at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalm.gov.ph>) and at the PSALM Office. The Invitation to Submit Proposal was also sent to at least three (3) suppliers of known qualifications;

WHEREAS, on 12 August 2021, no bidder submitted its proposal before the deadline for the submission at 1:00 PM;

WHEREAS, Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, **RESOLVE**, as it is hereby **RESOLVED**, to recommend for approval by the Head of the Procuring Entity the following:



2. Conduct of a re-bidding in accordance with the provisions of RA 9184 and its IRR.




