BAC RESOLUTION NO. SBAC-2021-108

- 1. DECLARATION OF THIRD FAILURE OF BIDDING; AND**
- 2. RECOMMENDATION FOR CONDUCT OF RE-BIDDING**

**FOR THE PROCUREMENT OF SUBSCRIPTION OF VIDEO CONFERENCING
SOFTWARE
(PROJECT REFERENCE NO. 2021-SVP-VCS-053-03)**

WHEREAS, the Power Sector Assets and Liabilities Management (PSALM) Corporation is a government-owned and -controlled corporation duly established under Republic Act (RA) No. 9136 to manage the privatization of assets of the National Power Corporation (NPC) transferred to PSALM with the objective of liquidating all NPC financial obligations in an optimal manner;

WHEREAS, RA 9184, otherwise known as the Government Procurement Reform Act, was enacted to modernize, standardize and regulate procurement activities governed by the principles on transparency, competitiveness, system of accountability, public monitoring and streamlined process;

WHEREAS RA 9184 likewise provides that all procurement should be within the approved budget and contained in the approved Annual Procurement Plan (APP);

WHEREAS, on 18 December 2020, the PSALM Board of Directors approved the APP for CY 2021 which includes the Procurement of Subscription of Video Conferencing Software (the "Project") with an estimated budget of One Hundred Fifty Thousand Pesos (PHP150,000.00);

WHEREAS, the Bids and Awards Committee (BAC), through BAC Resolution No. SBAC-2021-011, delegated the conduct of procurement for the Project to the Information Systems and Technology Department (ISTD) as the End-user;

WHEREAS, on 22 July 2021, the pre-procurement conference was conducted wherein the BAC approved the Request for Proposal (RFP), the Approved Budget for the Contract (ABC) in the amount of One Hundred Twenty-One Thousand Pesos (PHP121,000.00) and the timeline for the Project;

WHEREAS, on 28 July 2021, the RFP for the Project with Project Reference No. 2021-SVP-VCS-053-01 was sent out to at least three suppliers of known qualifications and at the same time, posted at the websites of the Philippine

Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalms.gov.ph>) and at the PSALM office for three (3) consecutive days;

WHEREAS, on 02 September 2021, the BAC, through BAC Resolution No. SBAC-2021-074, declared a failure of bidding for the Project with Project Reference No. 2021-SVP-VCS-053-01 pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184 and to conduct a re-bidding in accordance with RA 9184 and its 2016 Revised IRR;

WHEREAS, on 14 September 2021, the pre-procurement conference was conducted wherein the BAC approved the RFP, the ABC in the amount of One Hundred Twenty-One Thousand Pesos (PHP121,000.00) and the timeline for the Project;

WHEREAS, on 17 September 2021, the RFP for the Project with Project Reference No. 2021-SVP-VCS-053-02 was sent out to at least three suppliers of known qualifications and at the same time, posted at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalms.gov.ph>) and at the PSALM office for three (3) consecutive days;

WHEREAS, on 04 October 2021, the BAC, through BAC Resolution No. SBAC-2021-092, declared a failure of bidding for the Project with Project Reference No. 2021-SVP-VCS-053-02 pursuant to Section 35.1(a) of the 2016 Revised IRR of RA 9184 and to conduct a re-bidding in accordance with RA 9184 and its 206 Revised IRR;

WHEREAS, on 19 October 2021, the pre-procurement conference was conducted wherein the BAC approved the RFP, the ABC in the amount of One Hundred Twenty-One Thousand Pesos (PHP121,000.00) and the timeline for the Project;

WHEREAS, on 22 October 2021, the RFP for the Project with Project Reference No. 2021-SVP-VCS-053-03 was sent out to at least three suppliers of known qualifications and at the same time, posted at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalms.gov.ph>) and at the PSALM office for three (3) consecutive days;

WHEREAS, on 28 October 2021, the online/electronic submission and opening of proposal was conducted and one (1) interested bidder, Macrologic Diversified Technologies, Inc., submitted its proposal before the deadline for submission at 10:00 AM;

WHEREAS, during the preliminary examination of the eligibility documents, Macrologic Diversified Technologies, Inc. was rated "failed" for failure to submit its 1st Quarter of 2021 VAT Return (2550Q) as specified in the RFP;

WHEREAS, the TWG/End-User informed Macrologic Diversified Technologies, Inc. that they have three calendar days from 28 October 2021 within which to submit a request for reconsideration (RR) of the decision;

WHEREAS, Macrologic Diversified Technologies, Inc. informed the TWG/End-User that they will no longer file a RR;

WHEREAS, PSALM did not receive a RR from Macrologic Diversified Technologies, Inc. within the three (3) calendar days prescribed period or until 30 October 2021;

WHEREAS, Section 35.1(b) of the 2016 Revised IRR of RA 9184 provides that there shall be failure of bidding if the prospective bidder was declared ineligible;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the Members of the Bids and Awards Committee, **RESOLVE**, as it is hereby **RESOLVED**, to recommend for approval by the Head of the Procuring Entity the following:

1. Declare a **THIRD FAILURE OF BIDDING** for the Procurement of Subscription of Video Conferencing Software; and
2. Conduct a re-bidding for the Project in accordance with the provisions of RA 9184 and its 2016 Revised IRR.






