Glossary of Acronyms, Terms, and Abbreviations

ABC -Approved Budget for the Contract.

BAC - Bids and Awards Committee.

Bid - A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder - Refers to a Supplier, manufacturer, Supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents - The documents issued by the Procuring Entity as the basis for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR - Bureau of Internal Revenue.

BSP - Bangko Sentral ng Pilipinas.

Consulting Services - Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract - Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Supplier for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF - Cost Insurance and Freight.

CIP - Carriage and Insurance Paid.

CPI - Consumer Price Index.

DDP - **Refers to the quoted price of the Goods, which means “delivered duty paid.”**

DTI - Department of Trade and Industry.

EXW - Ex works.

FCA - **“Free Carrier” shipping point.**

FOB - **“Free on Board” shipping point.**

Foreign-funded Procurement or Foreign-Assisted Project-Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement - Refers to a written agreement between a procuring entity and a Supplier or Supplier that identifies the terms and conditions, under which **specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement.** It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI - Government Financial Institution.

GOCC -Government-owned and/or -controlled corporation.

Goods - Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring **Entity for such services. The term “related” or “analogous services” shall include,** but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP - Government of the Philippines.

GPPB - Government Procurement Policy Board.

INCOTERMS - International Commercial Terms.

Infrastructure Projects - Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information

technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs - Local Government Units.

NFCC - Net Financial Contracting Capacity.

NGA - National Government Agency.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project - refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA - Philippine Statistics Authority.

SEC - Securities and Exchange Commission.

SLCC - Single Largest Completed Contract.

Supplier - refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, Supplier, or consultant.

Section I. Invitation to Bid

Invitation to Bid

for the Procurement of Supply and Installation of Galvanized Roofing at PSALM Bagac Property Structures in Bagac, Bataan
(Project Reference No. 2022-PB-GRBPS-005-01)

1. The Power Sector Assets and Liabilities Management (PSALM) Corporation, through the 2022 Corporate Operating Budget intends to apply the sum of SEVENTEEN MILLION PESOS (PHP17,000,000.00) being the ABC to payments under the contract for the Procurement of Supply and Installation of Galvanized Roofing at PSALM Bagac Property Structures in Bagac, Bataan. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. PSALM now invites bids for the above Procurement Project. The estimated delivery of the Services is required by March 2022. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-**discretionary “pass/fail” criterion** as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183.

4. Prospective Bidders may obtain further information from PSALM Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below during Mondays to Fridays, 9:00 AM to 4:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting 09 February 2022 from the given address and website(s) below and upon payment of an applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of TWENTY-FIVE THOUSAND PESOS (PHP25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees through electronic means.

It may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS)

(<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalm.gov.ph>), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Thereafter, the Bidder must send the proof of payment and register its email address to the BAC Secretariat at BACSec2021@psalm.gov.ph.

6. PSALM will hold a Pre-Bid Conference on 17 February 2022 at 10:00 AM through videoconferencing or webcasting via Zoom, which shall be open to prospective bidders. Prospective bidders may manifest their intent to join the Pre-bid Conference by emailing the BAC Secretariat. Thereafter, the Meeting ID will be provided to the prospective bidders prior to the schedule.
7. Bids must be duly received by the BAC Secretariat through online or electronic submission as indicated below on or before 01 March 2022 at 10:00 AM. Late bids shall not be accepted. Personal or manual submission of bids shall not be allowed.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on 01 March 2022 at 10:15 AM through videoconferencing or webcasting via Zoom. Bids will be opened in the **presence of the bidders' representatives who choose to attend the activity.**
10. The detailed procedure for the electronic/online submission and opening of **bids is contained in Annex "A"** - General Policies and Procedures on Electronic/Online Submission and Receipt of Bids.
11. In case of electronic bid submission, Bidding Documents not in compressed archive folders and are not password protected, shall be rejected. However, bid envelopes that are not properly sealed and marked or not properly compressed and password-protected, as required in the Bidding Documents, shall be accepted, provided that the bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted.
12. PSALM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, PSALM Corporation, wishes to receive Bids for the Procurement of Supply and Installation of Galvanized Roofing at PSALM Bagac Property Structures in Bagac, Bataan, with Project Reference No. 2022-PB-GRBPS-005-01.

2. Funding Information

2.1. The GOP through the source of funding as indicated below for 2022 in the amount SEVENTEEN MILLION PESOS (PHP17,000,000.00).

2.2. The source of funding is the 2022 Corporate Operating Budget.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of R.A. No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or IB by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and **obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184** or other integrity violations in competing for the Project.

5. Eligible Bidders

5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

5.2. Foreign ownership limited to those allowed under the rules may participate in this Project.

- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the **PSA's CPI, must be at least equivalent to fifty percent (50%)** of the ABC.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under ITB Clause 18.

7. Subcontracts

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that subcontracting is allowed.

- 7.2. Subcontracting of any portion of the Project does not relieve the Supplier of any liability or obligation under the Contract. The Supplier will be responsible for the acts, defaults, and negligence of any subcontractor, its agents, servants, or workmen as fully as if these **were the Supplier's own acts, defaults, or negligence, or those of its agents, servants, or workmen.**

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address and/or through videoconferencing/webcasting as indicated in paragraph 6 of the IB.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the IB, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in Section VIII (Checklist of Technical and Financial Documents).

- 10.2. **The Bidder's SLCC as indicated in ITB Clause 5.3** should have been completed within five (5) years prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over **the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.**

11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in Section VIII (Checklist of Technical and Financial Documents).
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the IB shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
 - a. For **Goods offered from within the Procuring Entity's country:**
 - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
 - ii. The cost of all customs duties and sales and other taxes already paid or payable;

- iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
 - iv. The price of other (incidental) services, if any, listed if ever.
- b. For Goods offered from abroad:
- i. Unless otherwise stated in the BDS, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the BDS. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
 - ii. The price of other (incidental) services, if any, as listed in Section VII (Technical Specifications).

13. Bid and Payment Currencies

13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in Philippine Pesos.

14. Bid Security

14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the BDS, which shall be not less than the percentage of the ABC in accordance with the schedule in the BDS.

14.2. The Bid and bid security shall be valid until 29 June 2022. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

16. Deadline for Submission of Bids

16.1. The Bidders shall submit their bids on the specified date and time through online submission as indicated in paragraph 7 of the IB.

17. Opening and Preliminary Examination of Bids

17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the IB. **The Bidders'** representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of R.A. No. 9184.

18. Domestic Preference

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of **all Bids rated “passed,” using non-discretionary pass/fail criteria**. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of R.A. No. 9184.
- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by ITB Clause 15 shall be submitted for each lot or item separately.
- 19.3. The descriptions of the lots or items shall be indicated in Section VII (Technical Specifications), although the ABCs of these lots or items are indicated in the BDS for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.
- 19.4. The Project shall be awarded as one contract.
- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

20. Post-Qualification

- 20.1. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the BDS.

21. Signing of the Contract

- 21.1. The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the BDS.

1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of R.A. No. 9184 and its 2016 revised I.R.R., including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of R.A. No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the Special Conditions of Contract (SCC).

2. Advance Payment and Terms of Payment

2.1. Advance payment of the contract amount is **provided under Annex “D”** of the revised 2016 IRR of RA No. 9184.

2.2. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. The terms of payment are indicated in the SCC.

3. Performance Security

4. Inspection and Tests

The Procuring Entity shall notify the Supplier in writing, in a timely manner, of the identity of any representatives retained for these purposes.

All reasonable facilities and assistance for the inspection and testing of Goods, including access to drawings and production data, shall be provided by the Supplier to the authorized inspectors at no charge to the Procuring Entity.

5. Warranty

5.1 In order to assure that manufacturing defects shall be corrected by the Supplier, a warranty shall be required from the Supplier as provided under Section 62.1 of the 2016 revised IRR of RA No. 9184.

5.2 The Procuring Entity shall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall, repair or replace the defective Goods or parts thereof without cost to the Procuring Entity, pursuant to the Generic Procurement Manual.

6. Liability of the Supplier

The Supplier's **liability under this Contract shall be as provided by the laws of the Republic of the Philippines.**

If the Supplier is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

2.0 THE INSTALLATION OF GALVANIZED ROOFING

- (a) The supply and installation of galvanized roofing by the Supplier shall be in accordance with the standard practice adopting, as may be applicable, the National Building Code of the Philippines, its implementing rules and regulations, and other applicable government laws, rules, and regulations.
- (b) The installation of galvanized roofing and its accessories thereto shall conform in all respects to the principles of safe construction and must be suited to the purpose for which they are designed.
- (c) Before any installation work is commenced, the top face of the purlins should be checked for proper alignment. Correct the alignment as necessary in order to have the top faces of the purlins on an even plane.
- (d) Sheets shall be handled carefully to prevent damage to the paint coating. Lift all sheets or sheet packs on to the roof frame with the overlapping down-turned edge facing towards the side of the roof where installation will commence, otherwise sheets will have to be turned end-to-end during installation.
- (e) Gutters, valleys, flashing ridge and hip rolls shall be fastened by self-tapping screws or galvanized iron straps and rivets. Always begin flashing installation from bottom and work up, so that flashings are lapped on top of the lower flashings. This will prevent moisture from leaking under the flashings and into the structure.
- (f) Cutting galvanized roofing sheets and accessories shall be carried out on the ground and not over the top of other installed roofing product. Power cutting or drilling to be done or carried out on galvanized products already installed or laid in position.
- (g) For storage and protection. Galvanized roofing, and its accessories should be delivered to the jobsite in strapped bundles. Sheets and/or bundles shall be neatly stacked in the ground dry and if left in the open it shall be protected by covering the stack materials with loose tarpaulins. Bundles should be stored above ground at a slight angle, to prevent water or condensation build up between adjacent sheets. Removing installation debris and metal fines due to drilling and cutting from the sheet surface and avoiding exposure of insulation to the weather shall be practiced at all times.
- (h) Hauling and removal from the project site of the construction debris shall commence immediately after completion by the Supplier of the required tasks in disposal.
- (i) The Supplier shall repair/replace/reinstall necessary materials (e.g. purlins, trusses, gutters, ceilings etc.) during the installation of the galvanized roofing.

- (j) The Supplier shall provide necessary materials to ensure the water-tightness of the installed roofing.
- (k) As a requirement, the Supplier shall use gauge 20 to 22 galvanized long span roofing.
- (l) The Supplier must provide all necessary tools and equipment for the duration of the project.
- (m) The Supplier must provide necessary safety precautions (e.g. cordons, warning signs, PPE etc.) to avoid untoward incidents to the staff, guests, and tenants of the facility.

Section VII. Technical Specifications

Technical Specifications

A. SCOPE OF WORK

The scope of work of the Supplier shall cover the supply and installation of galvanized roofing at approximately 9,019 square meters of identified structures located at the PSALM Bagac Property in Bagac, Bataan as detailed in Section VI. Schedule of Requirements.

B. QUALIFICATION OF SUPPLIER

The Supplier:

1. Must have a licensed and experienced architect or civil engineer to supervise the entire duration of the project.
2. Must have at least a Construction Safety Officer 1, or higher, accredited by the Occupational Safety and Health Center (OSHC) or the Department of Labor and Employment (DOLE)-accredited Safety Training Organizations (STOs) to monitor the safety and health activities of the project.

C. RESPONSIBILITIES OF THE SUPPLIER

1. Assessment

1.1 The Supplier shall inspect, assess, and provide a monthly progress report to PSALM being the Procuring Entity, duly noted by the assigned PSALM representative.

2. Permits and Licenses

2.1 The Supplier shall secure and pay all the corresponding applicable local permits and licenses, including permits from the Municipal Building Official where the project is located.

2.2 The Supplier shall provide the PSALM Bagac Property Administrative Officer a copy of the said permits/certifications.

2.3 The Supplier shall secure and pay Occupancy Permit as required upon completion and/or turnover of the project.

3. Compliance to the COVID-19 IATF and Bataan LGU Safety Protocol

2.1 The Supplier, sub-Supplier (if applicable), and its employees shall submit the applicable documents upon entry to the PSALM Bagac Property in compliance with the Covid-19 IATF and Bagac LGU Safety Protocol.

Within Bagac:

- Identification Card (ID)
- Brgy. Certificate stating that he/she is not a member of a family under quarantine.

Within Bataan (Outside Bagac):

- Identification Card (ID)
- Medical Certificate issued by the Rural Health Unit (RHU) from the Brgy. where he/she came from.

Outside Bataan:

- Identification Card (ID)
- Negative RT-PCR Test result taken not more than 72 hours.

D. MATERIAL TESTING, INSTALLATION, TRANSPORT, AND DISPOSAL

1. The Supplier shall mobilize necessary resources such as personnel, packaging, safety materials, supplies, and equipment required for the completion of the project.
2. The Supplier shall conduct safety briefing in accordance with the Safety Plan and provide personnel with the required PPEs.
3. The PSALM representative and Supplier shall conduct testing and inspection of the materials in accordance with standards set by the National Building Code and PSALM as the Procuring Entity.
4. The Supplier shall establish site perimeter fence and install warning signs within the construction areas.
5. The Supplier shall install the galvanized roofing as specified in Item 2 of Section VI. Schedule of Requirements and in accordance with the schedule provided in Item 1 of the same section.
6. The construction materials, equipment, and debris shall be secured so as not to obstruct or create inconvenience to the facility operations and its guests, tenants, or employees.

7. The Supplier shall ensure and provide enclosure in the defined areas throughout the project duration using canvass material which shall ensure that the remaining structures are protected from environmental hazards which may result in their wear and tear.
8. After the Supplier of the Asbestos Roofing Removal has cleared the units to be re-roofed, the Supplier for the Supply and Installation of the Galvanized Roofing shall immediately commence its re-roofing activity on a per dismantled unit basis.
9. To achieve no. 8, the Supplier for the Supply and Installation of the Galvanized Roofing shall coordinate with the Supplier of the Asbestos Roofing Removal.
10. The Supplier shall hold PSALM free from claims from any party that may arise from any incidents whatsoever while the installation is being performed and shall defend PSALM against such claims at the Supplier's expense.
11. The Supplier shall ensure that the performance of its deliverables shall not disrupt the operations of the Bagac Facility.
12. The Supplier shall conduct removal of construction debris from the PSALM Bagac Property upon completion of the project.
13. The Supplier shall comply with all applicable laws, rules, and regulations in relation to the services being provided.

E. COMMENCEMENT AND DURATION OF THE CONTRACT

1. The Supplier shall perform its obligations under this contract within a period of One Hundred Sixty (160) calendar days (including mobilization/demobilization/material testing) which shall commence on the Effective Date as indicated in the Notice to Proceed (NTP) issued to the Supplier by PSALM in accordance with the following implementation schedule:

2. Mobilization of the Supplier’s **tools and equipment, accessories**, and manpower resources required to install the galvanized roofing at the identified PSALM Bagac Property Structures shall commence only upon issuance of **PSALM’s NTP**.
3. The Supplier shall provide PSALM a copy of the list of construction materials, equipment, names of personnel, permits, and other pertinent documents necessary for the completion of the project.
4. **The Contract is deemed completed upon PSALM’s** confirmation of the completion of supply and installation of galvanized roofing. PSALM will issue the **“Certificate of Acceptance”** as support for the billing of the final payment.

F. WORK SAFETY AND WORKING HOURS

1. The Supplier shall strictly observe all safety and security rules and regulations while inside the PSALM Bagac Property premises, including health protocols implemented by the site, and of the local and national government.
2. Work activities inside the PSALM Bagac Property premises shall be allowed only from 8:00 AM to 5:00 PM Monday to Friday. If Supplier intends to work beyond 5:00 PM and during weekends, authorization must be secured from PSALM.
3. The Supplier shall be responsible for ensuring the health and safety of its personnel assigned to and/or working within the PSALM Bagac Property, as well as the health and safety of any and all persons within the site who may be exposed to the works performed by the Supplier pursuant to the contract.
4. PSALM shall determine the location of the barracks to be utilized by the Supplier’s **staff and personnel for this project**.

G. PAYMENT

1. The payment for the services rendered shall be billed after five (5) days from the date of Certification of Completion by the PSALM Bagac Administrative Officer noted by the Manager, Administration and General Services Division, stating that all works specified in the contract has been completed.

2. The Supplier shall be paid by the Procuring Entity within sixty (60) days from receipt of the statement of account with complete documentations from the Supplier, unless there shall be any points of verification needed in the processing of the payment.
3. Other documents that shall be submitted for the processing of payment are as follows:
 - Statement of Account/Service Invoice/Billing Statement duly noted by the Bagac Property Administrative Officer;

H. LIABILITIES

The Supplier agrees that all information, in whatever form or medium, it may obtain from PSALM during the term of the Contract will be treated in strictest confidentiality and will never be disclosed to any party. I. PERFORMANCE SECURITY

2. Should any such force majeure or event occur, the Supplier shall promptly notify PSALM in writing and the contract period shall be reasonably extended if so warranted by the circumstances without any additional cost to PSALM. Unless otherwise directed by PSALM in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the *force majeure*.

K. LIABILITY AND LOSS AND/OR DAMAGES

1. The Supplier shall be liable and shall indemnify PSALM for any loss, damages or injury on property of PSALM due to or arising from the fault, negligence, vandalism, or other unlawful acts of its employees/workers, provided that the loss or damage is made known in writing by PSALM to the Supplier;
2. In cases where PSALM has provided tools and equipment to the Supplier, the latter shall indemnify PSALM for any loss or damages to such tools or **equipment while the same is in the latter's** possession, unless the loss or damage is caused by PSALM; and
3. PSALM shall, at its option, deduct from any money payable to Supplier any liability/indemnity incurred by it arising from the fault or negligence **of the latter's workers.**

 - 1.12 **the Entity’s Notice of Award;**

 - 1.14 the Office of the Government Corporate Counsel (OGCC) Contract Review No. ___, series of 2022 dated ___ 2022.

The documents mentioned above shall be collectively referred to as **“Contract Documents”**.

- 3.10 Separability Clause. Should any provision of this Contract be held invalid by any competent court, the same shall apply only to the provision involved and the remainder hereof remains valid and enforceable.
- 3.11 If any term or provision of this Agreement or the application thereof to any person or circumstances shall, to any extent, be invalid or unenforceable, the remainder of this Agreement or the application of such term or provision to person whose circumstances other than those as to which it was held invalid or unenforceable shall not be affected thereby.
- 3.12 The terms, conditions, and covenants of this Agreement shall be binding upon and shall inure to the benefit of the parties, successors, or assigns.
- 3.13 OGCC Approval. This Contract shall be subject to the review and approval of the Office of the Government Corporate Counsel. Any of its ensuing comments, recommendations, or directives shall form part of this Contract.

Legal Basis

The GPPB issued Resolution No. 09-2020 dated 07 May 2020 Approving Measures for The Efficient Conduct of Procurement Activities During A State of Calamity, or Implementation of Community Quarantine or Similar Restrictions. Among the measures introduced by the said Resolution are the following:

- a. All Procuring Entities (PE) are now encouraged to maximize the use of videoconferencing, webcasting and similar technology in the conduct of any of the BAC meetings and the determination of a quorum by the Bids and Awards Committee (BAC). The use of digital signatures in procurement related documents is also encouraged.
- b. Bids may now be submitted through on-line submission. The online or electronic submission and receipt of bids for procurement modalities where a two-envelope procedure or sealed price quotation and use a two-factor security procedure consisting of an archive format compression and password protection is required.
- c. The BAC shall decide whether to allow the online or electronic submission and **receipt of bids based on the PE’s procurement needs and capabilities. It shall ensure the security, integrity and confidentiality of the bids submitted and generate an audit trail of transactions for the security, integrity and authenticity of the bid submissions.**

8. If successful, the modified file capacity size should be smaller than the original.



Opening of Bids

1. The BAC shall open the bids immediately after the deadline for submission and receipt of bids, and on the bid opening date.
2. During the bid opening, the BAC will make use of appropriate teleconferencing software wherein all bidders are invited to participate including the observers.
3. Before the decryption of electronic bids, the Bidder shall confirm that what the BAC received and what the BAC is about to open is the same file that the Bidder uploaded.
4. The passwords for accessing the files will be disclosed by the Bidder only during the actual bid opening through videoconferencing, webcasting or similar technology. If the password fails to open the file, the Bidder should be given only three tries until the BAC could declare it to be disqualified.
5. The BAC shall open the first PDF file of the Bidder who submitted bids electronically to determine each Bidder's **compliance with the documents** required to be submitted for eligibility, that is, legal, technical and financial eligibility documents; and for the technical requirements. For this purpose, the BAC shall check the submitted documents of each Bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary **"pass/fail" criterion. If a Bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed". Otherwise, the BAC shall rate the Bidder "passed" in relation to the eligibility and technical documents in the first PDF file.**
6. Immediately after determining compliance with the requirements in the first PDF file, the BAC shall open the electronically submitted second PDF file of **each eligible Bidder whose first PDF file was rated "passed."** The second PDF file of each complying Bidder shall be opened within the same day.
7. The BAC shall thereafter proceed to decrypt the electronic Second PDF file of each **On-line Bidders whose electronic first PDF file was rated "passed" to determine each Bidder's compliance with the required financial documents.**
8. In case one or more of the requirements in the second PDF file of a particular bid is missing, incomplete or patently insufficient, and/or if the submitted total bid price exceeds the ABC, the BAC shall rate the bid concerned as **"failed"**.
9. Only bids that are determined to contain all the bid requirements for both **components shall be rated "passed" and shall immediately be considered for evaluation and comparison.**

The BAC shall then:

- a. Record all the financial bids but should not be visible to all participants.
- b. After all the financial bids were recorded, the BAC finally shows the financial bids of all bidders and declare who among the bidders is the lowest bidder.

- 1. Valid PhilIGEPS Registration Certificate (Platinum Membership) (all pages);

or
- 2. Registration certificate from Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives or its equivalent document,

and
- 3. **Mayor's or Business permit issued by the city or municipality** where the principal place of business of the Subcontractor is located, or the equivalent document for Exclusive Economic Zones or Areas;

and
- 4. Tax clearance per E.O. No. 398, s. 2005, as finally reviewed and approved by the Bureau of Internal Revenue (BIR).

Technical Documents

- 5. Statement of the subcontractor of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the portion of the Project to be subcontracted; and
- 6. **Statement of the subcontractor's Single Largest Completed Contract (SLCC)** similar to the portion of the Project to be subcontracted, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period as provided in the Bidding Documents.

Financial Documents

- 7. **The Subcontractor's audited financial statements, showing, among others, the Subcontractor's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and**

authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission; and

8. **The Subcontractor's computation of Net Financial Contracting Capacity (NFCC);**

or

A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation; and

9. Any document that shows the amount intended for subcontracting of a portion of the project in order to determine if it complies with the twenty percent (20%) limitation of subcontracting of the project.

Class "B" Documents

10. If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence;

or

duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful.

Other documentary requirements under RA No. 9184 (as applicable)

11. **[For foreign subcontractor claiming by reason of their country's extension of reciprocal rights to Filipinos]** Certification from the relevant government office of their country stating that Filipinos are allowed to participate in government procurement activities for the same item or product.
12. Certification from the DTI if the Subcontractor claims preference as a Domestic Subcontractor or Domestic Entity.
