

Invitation to Bid

for the Procurement of Security Services for Various Plants, Facilities and Installations for CY 2020

- The Power Sector Assets and Liabilities Management (PSALM) Corporation, through the 2021 Corporate Operating Budget (for the portion of the Contract to be performed in 2021) and 2022 Corporate Operating Budget (for the portion of the Contract to be performed in 2022), intends to apply the sum being the respective Approved Budgets for the Contract (ABC) to payments for each of the projects listed below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- PSALM now invites bids for the above Procurement Projects. The estimated delivery of the Goods is required by May 2021. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations.
- Prospective Bidders may obtain further information from PSALM Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below during Monday to Friday, 9:00 AM to 4:00 PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders starting **27 February 2021** from the given address and website(s) below and upon payment of an applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through electronic means.
