

# Invitation to Bid

## for the Procurement of Supply and Delivery of Diesel Oil for Malaya Thermal Power Plant for CY 2020

- The Power Sector Assets and Liabilities Management (PSALM) Corporation, through the 2020 Corporate Operating Budget, intends to apply the sum being the Approved Budget for the Contract (ABC) to payment for the project listed below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- PSALM now invites bids for the procurement of **Supply and Delivery of Diesel Oil for Malaya Thermal Power Plant for CY 2020**. Delivery of the Goods is required as indicated in Section VI. Schedule of Requirements of the Bidding Documents. Bidders must have completed, within three (3) years from the date of submission and receipt of bids, a single contract similar to the Project, value of which is equivalent to at least twenty-five (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

- A complete set of Bidding Documents may be acquired by interested bidders beginning on 2 July 2020 from the address below and upon payment of an applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB.

It may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalm.gov.ph>), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bid.

Thereafter, the Bidder must send the proof of payment and register its email address to the BAC Secretariat at [bacsec2020@psalm.gov.ph](mailto:bacsec2020@psalm.gov.ph) and [bid.submission@psalm.gov.ph](mailto:bid.submission@psalm.gov.ph).

5. PSALM will hold a Pre-Bid Conference on **10 July 2020, 11:00 AM** through videoconferencing/webcasting. Prospective bidders may manifest their intent to join the Pre-Bid Conference by emailing the BAC Secretariat. Thereafter, the Meeting ID will be provided to the prospective bidders prior to the schedule.
6. Bids must be duly received by the BAC Secretariat at the PSALM electronic/online platform on or before **23 July 2020, 9:30 AM**. Personal or manual submission of bids shall not be allowed. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The detailed procedure for electronic/online bid submission is contained in Annex "C" - General Policies and Procedures for Electronic/Online Submission and Receipt of Bids.

7. Bid opening shall be on **23 July 2020, 10:30 AM** through videoconferencing/webcasting. The Meeting ID will be provided to the Bidders prior to the schedule. Bids will be opened and can be viewed by the bidder or its representatives through electronic/online bid opening. Late bids shall not be accepted.

The detailed procedure for electronic/online bid opening is contained in Annex "C" - General Policies and Procedures for Electronic/Online Submission and Receipt of Bids.

8. Provisionary Tax Clearance is not acceptable.
9. PSALM reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


