**1. NOTICE TO BIDDERS**

Bidders are hereby notified of the amendments, revisions, modifications and clarifications to the Bidding Documents dated 24 January 2020 for the Procurement of Operation and Maintenance Service Contract for the Malaya Thermal Power Plant located at Pililla, Rizal.

In compliance with Presidential Proclamation Nos. 922 and 929, series of 2020, to minimize health risks to PSALM personnel and prospective bidders, PSALM hereby forms a skeletal workforce and adopts stringent social distancing office policies: (1) to ensure performance of all critical, urgent and necessary functions and (2) to ensure timely achievement of all mandates and objectives.

This Supplemental Bid Bulletin, therefore, is being issued pursuant to the abovementioned Presidential Proclamations.

In any case, it is conclusively presumed that the Bidder, in preparing their bids, has taken into account the information and procedures set forth in the ITB.


