- 1. DECLARATION OF FAILURE OF BIDDING; AND**
- 2. RECOMMENDATION FOR CONDUCT OF RE-BIDDING**

**FOR THE PROCUREMENT OF LEASE OF VENUE FOR PSALM'S PLANT VISIT AT
THE CASECNAN HYDROELECTRIC POWER PLANT, REGULAR BOARD MEETING
AND TRANSITION PLANNING
(PROJECT REFERENCE NO. 2022-NP-LRPV-BTPVC-015-01)**

WHEREAS, the Power Sector Assets and Liabilities Management (PSALM) Corporation is a government-owned and -controlled corporation duly established under Republic Act (RA) No. 9136 to manage the privatization of assets of the National Power Corporation (NPC) transferred to PSALM with the objective of liquidating all NPC financial obligations in an optimal manner;

WHEREAS, RA 9184, otherwise known as the Government Procurement Reform Act, was enacted to modernize, standardize and regulate procurement activities governed by the principles on transparency, competitiveness, system of accountability, public monitoring and streamlined process;

WHEREAS RA 9184 likewise provides that all procurement should be within the approved budget and contained in the approved Annual Procurement Plan (APP);

WHEREAS, on 27 October 2021, the PSALM Board of Directors approved the PSALM APP for CY 2022 which includes the Procurement of Lease of Venue for PSALM's Board Meeting/Other Board-Related Expenses (Strategic Planning) with an estimated budget of Nine Hundred Sixty Thousand Pesos (PHP960,000.00);

WHEREAS, on 03 November 2021, the PSALM President and CEO, as authorized by the PSALM Board of Directors, signed the APP for CY 2022;

WHEREAS, the Bids and Awards Committee (BAC), through BAC Resolution No. SBAC-2022-002 dated 13 January 2022 authorized the Office of the Corporate Secretary (OCS), as the End-user of the Project, to conduct Negotiated Procurement (Small Value Procurement and Lease of Real Property and Venue) as an alternative method of procurement;

WHEREAS, on 12 April 2022, the pre-procurement conference was conducted wherein the Bids and Award Committee (BAC) approved the Request for Quotation (RFQ), Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos

(PHP300,000.00) and the timeline for the Procurement of Lease of Venue for PSALM's Plant Visit at the Casecnan Hydroelectric Power Plant, Regular Board Meeting and Transition Planning (the "Project");

WHEREAS, on 13 April 2022, the RFQ for the Project with Project Reference No. 2022-NP-LRPV-BTPVC-015-01 was sent out to at least three (3) lessors of known qualifications and at the same time, uploaded at the websites of the Philippine Government Electronic Procurement System (<https://www.philgeps.gov.ph>) and PSALM (<https://www.psalm.gov.ph>) and at the PSALM Office for three (3) consecutive days;

WHEREAS, on 18 April 2022, the date of the Opening of Quotations for the Project, no bidder submitted its quotation by the deadline for the submission at 10:00 AM;

WHEREAS, Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the Members of the Bids and Awards Committee, **RESOLVE**, as it is hereby **RESOLVED**, to recommend for approval by the Head of the Procuring Entity the following:

1. Declare a **FAILURE OF BIDDING** for the **Procurement of Lease of Venue for PSALM's Plant Visit at the Casecnan Hydroelectric Power Plant, Regular Board Meeting and Transition Planning**; and
2. Conduct a re-bidding for the Project in accordance with the provisions of RA 9184 and its 2016 Revised IRR.
